Raffle Narrative

Winner does not need to be present to win. Only official drawing tickets will be accepted, no photocopies permitted. Winner must claim prize within 90 days of drawing or prize will be donated to Friends of Guest House. Current members of the Board of Directors of Friends of Guest House, staff and their immediate households are not eligible to win. Winner must be 18 years of age or older, provide a valid Social Security number, and pay federal and state withholding taxes before prize can be claimed. The winner is also responsible for license, title, registration and other expenses associated with the prize. Participants agree to release Friends of Guest House and Alexandria Toyota from any liability resulting from participation in

opportunity drawing or use of any prize. No part of the ticket purchase qualifies as a charitable contribution.

House Rules

1. The purchase price of each ticket is \$100.
2. Tickets are “bearer instruments” and may be given as gifts to other individuals by the purchaser. In such case, the ticket holder, not the ticket purchaser, is entitled to any winnings associated with the ticket, provided that the ticket holder is not a person prohibited from winning under paragraph 10 below.
3. If a ticket is purchased by check or credit card that does not clear when presented to the bank, the holder of that ticket is ineligible to win.
4. Each ticket gives the ticket holder one chance to win. The prize shall be a 2016 Scion iA, from Jack Taylor’s Alexandria Toyota subject to all other provisions of the Raffle House Rules set forth therein.
5. There is no limit to the number of tickets that may be purchased by a single individual or the number of tickets that may bear the name of a single individual.
6. Tickets may not be sold to individuals who have not reached the age of eighteen by the date of the drawing, October 21, 2017. The winner of the raffle must have reached the age of eighteen by the date of the drawing, October 21, 2017.
7. The winner does not need to be present at the drawing to win. The Executive Director will contact the winner using the contact information provided on the ticket stub. The winning ticket number will be posted on the Guest House’s web site www.friendsofguesthouse.org. If the prize is not claimed within 90 days of the drawing or is refused by the winner within 90 days of the drawing, then the prize shall be null and void and car shall go to Friends of Guest House.
8. The winner must provide a valid U.S. Social Security number, complete a W-9, I-9 (including required identification), IRS 5754 (as needed), and any other forms required by state, city, or federal law to claim the prize. Participants agree to release Friends of Guest House and Alexandria Toyota from any liability resulting from participation in this opportunity drawing or the use of any prize.
9. If the prize is claimed by the winner, the winner will be responsible for all taxes associated with the prize. Acceptance of a prize constitutes permission for Friends of Guest House and Jack Taylor’s Alexandria Toyota and their designees to use the winner’s name, photograph, testimonial or other likeness and/or prize information or personal exposition (and/or any edited portion thereof) for promotional advertising and/or publicity purposes in any media, now or hereafter, without compensation or notice to, or further consent of, the winner to the greatest extent permitted by law.

10. Current members of the Board of Directors of Friends of Guest House, the Executive Director and staff of Friends of Guest House as well as members of their immediate households are ineligible to win.

11. Any unsold tickets must be returned to the Executive Director and will be voided.

12. All net proceeds from the raffle will benefit Friends of Guest House.

13. Winner must agree to all rules as stated in the Raffle Narrative, House Rules, and rules printed on the ticket.

14. Ticket stubs and unsold tickets will be maintained in the office of Friends of Guest House for a period of three years from the close of the fiscal year in which the raffle is held.

15. The raffle drawing will be conducted October 21, 2017. The winning ticket will be drawn in a blind drawing. A box containing all of the purchased ticket stubs will be presented. A blind drawing will be held (the person pulling the ticket will not be able to see into the box). The winner of the raffle will be announced at the time of the drawing.

16. The winner does not need to be present to win. If the winner is not present, the Executive Director will contact the winner using the contact information on the ticket stub. If the prize is not claimed within 90 days of the drawing or is refused by the winner within 90 days of the drawing, then the prize shall be null and void and the vehicle shall remain with Friends of Guest House.
